Frank Suder, Fritz Thyssen Foundation, Cologne Since 2014, Frank Suder has been Director of the Fritz Thyssen Foundation, Cologne. Prior to that, he worked as the personal assistent to the President of the German Research Foundation (DFG) and as Deputy Director of the Fritz Thyssen Foundation. Frank Suder holds a PhD in biology from the University of Cologne.

Jaap de Zwaan, Erasmus University Rotterdam Professor Jaap W. de Zwaan is Secretary-General of the the Trans European Policy Studies Association (TEPSA), an emeritus Professor of law of the European Union at the law school of Erasmus University Rotterdam and lecturer for European Integration at the The Hague University of Applied Sciences. He studied law at Leiden University and the College of Europe in Bruges, Belgium. In 1993, he obtained his PhD degree in law at the University of Groningen.



Mirja Schröder, University of Cologne

Mirja Schröder is Research Associate at the Jean Monnet Chair for Political Science at the University of Cologne. She has been working as project manager of the THESEUS network since 2011. In 2013, she was awarded with the University award for teaching. Her main research interests are European energy policy, as well as the role of the Franco-German relationship for European integration. In her PhD, she focuses on the EU's external energy policy with special regard to gas supply security.













Wolfgang Wessels, University of Cologne

Prof. Dr. Wolfgang is Chairholder of the Jean Monnet Chair for Political Science at the University of Cologne. He is involved in several research and teaching networks such as THESEUS, EUCOPAS and FEUTURE. He is Chairperson of the Executive Board of the Institut für Europäische Politik (IEP) in Berlin and of the Executive Board of the Trans European Policy Studies Association (TEPSA) in Brussels. He is Vice-President of the German consortium for the foundation of the Turkish-German University, Istanbul. His areas of research include the political system of the European Union, the deepening and widening of the EU, modes of governance as well as theories and strategies of European integration.

From 1969 to 1973, she was director of the Institut für Europäische Politik, the former Bildungswerk Europäische Politik, Cologne.



Hartmut Kaelble, Humboldt-University Berlin Hartmut Kaelble is Professor emeritus at the Institute for Historical Sceiences at Humboldt-University Berlin. His research focuses on the history of European integration and the comparative social history of Europe, especially of social inequality and the welfare state.















Wilfried Loth, University of Duisburg-Essen Wilfried Loth is Professor emeritus of Modern and Contemporary History at the University of Duisburg-Essen. His major academic interests include the history of European integration, the history of catholicism and of socialism, the history of the German empire, the history of France in the twentieth century and the history of the Cold War.





Johannes Pollak, Institute for Advanced Studies, Vienna

Johannes Pollak is Head of the research group on European Integration and Professor of political science at Webster University Vienna. He studied political science and philosophy at the University of Vienna, the Institute for Advanced Studies, Vienna, and the London School of Economics and Political Science (LSE). Research areas are questions pertaining to the quality of European democracy and political representation as well as the phenomenon of agencification to European energy policy.

Gaby Umbach, European University Institute, Florence

Gaby holds a PhD in Political Science from the University of Cologne, where she was Senior Research Associate of the Jean Monnet Chair for Political Science and of the seminar for Social Policy from 2000 to 2014. In 2010, she joined the European University Institute for a Jean Monnet Fellowship. Since 2011, she has been part of the European University Institute's (EUI's) Global Governance Programmes faculty, where she is founding Director of GlobalStat. Since July 2015, she has served as book review editor of the Journal of Common Market Studies (JCMS) and in October 2015, she became member of the EUI's Ethics Committee. Her research focus includes a broad range of European integration topics as well as key aspects of global governance and sustainable development.

Jörg Monar, College of Europe, Bruges

Professor Jörg Monar has been Rector of the College of Europe (Bruges/Natolin) since September 2013. He holds a Doctorate in modern history from the University of Munich and a Doctorate in Political and Social Sciences from the European University Institute in Florence. His over 200 publications relate mainly to European Union justice and home affairs, external relateions and the institutional development of the Union. He is also a founding editor of the European Foreign Affairs Review.



Christine Neuhold, University of Maastricht

Christine Neuhold is Professor of the Department of Political Science, Faculty of Arts and Social Sciences (FASoS), Maastricht University. She is a political scientist by training and holds her doctoral degree from the University of Vienna. She has been involved in more than ten international research projects on EU integration, both as a team member and as a co-ordinator. The most recent Innovative Training Network (ITN) she coordinated focused on inter-institutional cooperation in the EU and led to a special issue on this subject.













Olivier Rozenberg, Sciences Po Paris

Olivier Rozenberg is Associate Professor at Sciences Po Paris of the Centre d'études européennes. He is specialises in legislative studies (legislators' behaviour, comparative studies), in European studies (EU institutions, France in Europe), and in the role of parliaments in the governance of the EU. He has published a number of collective books, including Parliamentary Roles in Modern Legislatures (with Magnus Blomgren, Routledge, 2012) and The Roles and Function of Parliamentary Questions (with Shane Martin, Routledge, 2012). He is co-editor of the Palgrave Handbook on National Parliaments and the European Union.



Philippe de Schoutheete, Egmont Royal Insitute for International Relations, Brussels

Baron Philippe de Schoutheete, former Belgian diplomat, was Ambassador in Madrid, Political Director at the Belgian Foreign Ministry and Belgium's permanent representative to the European Union from 1987 to 1997. He was special adviser to Commissioner Michel Barnier. In addition, he has been Visiting Professor at the University of Louvain and at the College of Europe in Natolin (Poland). He is now Senior Fellow of the European Department of Egmont Royal Institute.

His research focuses on European integration and, more specifically, integration theory, enlargement, differentiated integration, democracy promotion, and democratization.

She holds a PhD from the Faculty of Management, Economics and Social Sciences at the University of Cologne.
